NEW HOUSING

At present there are approximately 440 households within the two Sibford Parishes, including Sibford School. Cherwell Local Plan proposed 50 new houses in the Sibfords by 2026 amounting to approximately 11% of the total number of existing houses. After a public meeting the Parish Councils replied to Cherwell District Council on behalf of the residents, proposing no more than 10 to 20 new houses. It is still likely that the Sibfords will be expected to provide for expansion under the new Local Development Framework. Cherwell housing policy currently requires one third of new housing to be affordable housing.



LOCATION OF NEW HOUSING

The Sibfords have grown up with green spaces between and within them, allowing access to and views across the surrounding countryside. The Local Plan states that villages should be extended to relate to their historic growth pattern and this should allow for extending outside the village 'envelope' with open space integrated within or between new developments. If all new housing is 'infilling' then much of the existing open space within the Sibfords may well be lost and any further housing will have to be outside the village 'envelopes'.


